

2026 BLUE & GRAY BBQ CELEBRATION APPLICATION

The Blue & Gray Barbecue Celebration will take place on Saturday September 19, 2026, from 10 am to 4 pm. The event will be hosted by the Friends of the Gordon-Lee Mansion.

The area for food vendors will be on the **newly paved exit** road on the Mansion grounds. The Mansion entry must remain open to traffic – do not block. Other vendors and crafts will be placed in the yard area between exit road and walk path to Mansion. Vendors please remain open until 4 pm, please remove all trash.

All spaces will be 15'X 20' wide. The tent, cookers, tables, etc must fit inside the assigned area. Food vendors Fee is \$75. Craft fee is \$50, information only space is \$25. If an additional 10 ft width is desired the cost is an additional \$25, subject to space availability. Vendors can set up on Friday, Sept 18th, between 5pm and 9 pm and must be setup and ready by 10 am on Sept 19th.

No alcoholic beverage consumption will be allowed on Mansion grounds. Liability insurance will not be provided. No Refunds due to cancellations after Sept 1, 2026, or for no-shows or inclement weather.
